## **SUMMARY OF REQUEST:**

During the fall of 2017 Hurricane Harvey struck Texas. As part of a "Emergency Management Assistance Compact" request (EMAC) North Carolina deployed five swiftwater rescue teams to College Station, TX to provide additional support. As part of the response Henderson County sent 18 personnel with equipment to assist our neighbors to the west.

As part of the Statewide Mutual Aid agreement NC Emergency Management provides reimbursement for approved missions. Henderson County Emergency Management staff worked in conjunction with our partner agencies to compile the costs of the deployment which were submitted early 2018. The State provided a partial reimbursement of \$51,587.26 to Henderson County for the costs of the deployment. These funds will be distributed to the deployed Fire Departments, Rescue Squad and to reimburse the County for expenses incurred.

The Board is requested to approve the attached Budget Amendment.

I move the Board approve the budget amendment authorizing the receipt of funds as reimbursement for the Hurricane Harvey deployment and provide reimbursement to the partner agencies as approved in the State reimbursement package.
