#### **SUMMARY OF REQUEST:**

The County has received a request from Sierra Nevada Brewing Co. (SNBCo) for the use of the 1995 Courthouse north parking lot, off of 4<sup>th</sup> Ave. The request letter is attached. This request is associated with SNBCo's 2019 Oktoberfest festival on October 12, 2019.

SNBCo proposes to utilize the parking lot as "a central and safe location for residents to load/un-load" the SNBCo shuttle bus. During the event, the shuttle bus will provide safe and complementary transportation between Hendersonville and the brewery in Mills River.
