SUMMARY OF REQUEST:

In May of this year, the Board of Commissioners approved the contracting of Stewart Consultants for the facilitation of the new Henderson County 2045 Comprehensive Plan. This plan, required by NC General Statutes, will provide a guideline for growth and development in the County.

The plan requires extensive public input and involvement, which equates to a long planning process. The consultants have divided the estimated 18-month process into three phases. We are currently in Phase 1. The Board will receive regular monthly updates throughout the process.

COMPREHENSIVE PLANNING PROCESS UPDATE

PHASE 1

The comprehensive plan is a detailed plan that will take 18 months to complete. The process is broken into three phases. Phase 1 is anticipated to run through the end of 2021.

Phase 2 will begin in January when the Planning Board, serving as the Steering Committee, begins their "visioning" process.

OCTOBER 2021 UPDATES

COMMUNITY SURVEY

- Staff are continuing to receive returned surveys from the tax bill.
 - Over 2,000 paper surveys returned
- The online survey received over 3,000 responses

OPEN HOUSE EVENTS

- Since the last update, staff conducted 4 open house events.
- These events are drop-in style and have multiple interactive stations that are self-guided. Staff are available at each station to answer questions and facilitate critical thinking.
- These events generated interest in the plan and engaged many community participants.

STAKEHOLDER MEETINGS

- Meeting summaries of the stakeholder meeting series held in August are now available online.
- Staff and the consultant continue to meet with key stakeholders regarding their unique perspectives of the County.

MEETING IN A BOX

- The "Meeting in a Box" is available online at www.HendersonCounty2045.com.
- Unfortunately, staff cannot present at every club or organization's meeting. This online tool will allow small groups to conduct their own meetings and submit their feedback to become part of the record.

REACHING OUT!

- Based on the Board's previous comments, the consultant is currently developing methods to ensure outreach to under-represented communities.
- In partnership with the City of Hendersonville, staff participated in a two-day diversity and inclusion training.
- Comprehensive plan materials like the survey and open house flyers are available in Spanish. All other languages will be made upon individual request.
- Staff will conduct a stakeholder meeting with the City's Diversity, Equity, and Inclusion Committee
 in November.

- All members of the community are encouraged to attend an Open House Meeting in addition to
