## **SUMMARY OF REQUEST:**

The Solid Waste 3<sup>rd</sup> Transfer Station Bay project is anticipated to be completed in April 2025. To prepare for completion and operation of the third bay, Solid Waste requires an additional spotter truck and loader tamp as well as additional staff for heavy equipment operation. The lead time to purchase the equipment is approximately five months. Additional staff will require training time of two to three months before the third bay is operational.

Staff is requesting to appropriate retained earnings of \$240,000 to fund the purchase of the equipment and hiring of two additional staff members.

## **BOARD ACTION REQUESTED:**

The Board is requested to approve the addition of two heavy equipment operator positions for the Solid Waste Department. The Board is also requested to approve the budget amendment to appropriate retained earnings for the purchase of equipment and hiring of additional staff.
