SUMMARY OF REQUEST:

Apple Country Public Transit (ACPT) is the only fixed-route transit system in the county. Many people depend on the system for their daily commute and as a primary transportation method. Hurricane Helene caused many Henderson County residents to lose their vehicles, increasing dependence on the transit system. In response to the federally declared natural disaster, the Planning Department proposes two temporary alleviation measures.

Currently, ACPT operates Monday – Friday, 6:30 AM to 6:30 PM. Working within the confines of our contractor's capacity, the Department suggests expanding service by one hour daily, ending at 7:30 PM. Additionally, to assist our struggling community, the Department proposes to remove transit fares from the fee schedule effective December 3, 2024. The extended service will begin when WNCSource has sufficient capacity (expected at the beginning of 2025) and will run through the end of the fiscal year, barring any issues that would be cause for early termination. Both measures will be temporary to comply with Federal Transit Administration regulations. The Board may decide during their FY2026 budget meetings whether they wish to continue these measures.

BOARD ACTION REQUESTED:

The Board is requested to approve temporary service expansion and the temporary waiver of transit fares effective December 3, 2024, through June 30, 2024.

<u>CONTRACT ADDENDUM</u> HENDERSON COUNTY TRANSIT CONTRACT APPLE COUNTRY PUBLIC TRANSIT

This Agreement made and entered this the of, 2024, by and between Henderson County , a body politic and corporate under the laws of the State of North Carolina (hereinafter the "COUNTY") and Western Carolina Community Action (hereinafter the "SERVICE PROVIDER"), a nonprofit organization doing business as WNCSource, is an addendum to the original agreement signed on May 18, 2022 by the Parties.
Witnesseth
WHEREAS Hurricane Helene hit Henderson County on September 27, 2024, and the Henderson County Board of Commissioners seeks to alleviate burdensome costs and wishes to expand access to those affected; and
WHEREAS the County and the Service Provider have had an agreement for transit services since 18 th May, 2022; and
WHEREAS the Federal Transit Administration grants Henderson County the authority to temporarily amend contracts without following major service change procedures; and
WHEREAS the previous agreement allows the County and the Service Provider to amend and create addendum to the agreement; and
WHEREAS the County is to amend the current agreement; and
WHEREAS this addendum is for the purposes of temporary changes only to take effect from January 2, 2025 through June 30, 2025;

NOW THEREFORE, for valuable consideration and mutual promises, the adequacy and sufficiency of

which is hereby acknowledged, the parties hereto agree as follows:

1. AMENDMENT:

- a. The SERVICE PROVIDER will <u>temporarily</u> extend all three Fixed-Route service routes by 1 (one) hour each for the period from January 2, 2025, to June 30, 2025, for a maximum total of 375 additional service hours.
- b. The SERVICE PROVIDER will <u>temporarily</u> extend Paratransit services by 1 (one) hour for the period from January 2, 2025, to June 30, 2025, for a maximum total of 125 additional service hours.
- c. Both Fixed-Route and Paratransit services will <u>temporarily</u> operate fare-free for all riders for the period from December 3, 2024, to June 30, 2025.

- d. The SERVICE PROVIDER shall not charge greater than the "not to exceed" amount for Fixed-Route service listed in the Table in ATTACHMENT 1, "Cost of Additional Service Hour."
- e. The SERVICE PROVIDER shall not charge greater than the "not to exceed" amount for Paratransit service listed in the Table in ATTACHMENT 1, "Cost of Additional Service Hour."
- 2. ORIGINAL TERMS: Apart from the revisions outlined in the "Amendments" section, all remaining terms, conditions, clauses, and provisions in the Original Agreement remain unaltered and in full force for the duration of this Agreement, including all federal requirements from the Federal Transit Administration.
