SUMMARY OF REQUEST:



Petition request for the <u>partial abandonment</u> of Secondary Road <u>SR 1340</u> from the State Maintained System.

Partial abandonment begins at Station 25+40 on Dalton Road and continues in a North-Westerly direction to the end of road at Station 52+62. The total distance for the abandonment will be 2722 feet. The total length of road that will remain on the State Maintained System will be 2540 feet.

NOTE: NCDOT Right-of-way will include 10 feet beyond cross-pipe. Cross-pipe will be maintained by the NCDOT.
