Minutes of Board Meeting
October 8, 2024

The Board of Elections met on October 8, 2024, at 5:00 PM at the Henderson County Board of Elections office at 75 E. Central Street. Members present were Clay Eddleman, Chair, Debbie Dante, Secretary, Linda Rebuck, Sharon Pearson, Cindy Ellis, Members, and Summer Heatherly, Director. Staff present: Aaron, Chastity and Mary K.

Pledge

Minutes: Minutes were approved for 5/24/24 and 9/16/24. Correction made to 9/16/24, to wit: Motion to put matter behind us and move on with our work in the General Election passed with 4 yea and 1 abstention (Member Ellis). Member Dante notes that it is not good practice to abstain from a vote and will supply that information to the Board.

Agenda: Chair suggested moving Election Day Resolution to next Tuesday's meeting. Linda moved to approve the Agenda. Cindy 2nd. Passed unanimously.

Old Business: None.

Directors Comments. The State Board Resolution dated October 7, 2024 (attached). Highlights include issuing ballots over the counter. Absentee Request forms will be verified before a ballot is issued. Mat teams can be deployed to disaster shelters or other places where disaster relief is provided, in addition to care facilities. Absentee ballots may be dropped off at any county election office or precinct on Election Day.

New Business: Future Election Site. The Board's request to the County Commissioners to purchase the BOE building currently rented, was denied. In lieu, they agreed to lease the field across from the office, owned by the Vet, on even numbered years, for poll worker and observer parking.

Early Voting Resolution. The County is currently under a curfew of 10 pm to 8 am. As a result, Early Voting hours required a change to 9 am to 8 pm and open on all 3 Saturdays from 9 am to 3 pm. Linda moved to adopt the amended hours on the Resolution for General Election Early Voting Days and Hours (attached). Sharon 2nd. Passed unanimously.

Member Dante began discussion regarding opening additional early voting sites due to the state of emergency. Majority of members agreed that the MAT teams would be a better option instead. Cindy moved that the Director should give the Board a MAT team Plan by the next meeting. Sharon 2nd. Passed by unanimous vote.

Approval of Absentee Ballots. Absentee tabulator # 1 (#18365) seal #230879 was removed and ballot box was empty. Absentee tabulator # 2 (#18361) seal # 230878 was removed and ballot box was empty. Zero tape was run on Absentee tabulators and signed by the Board. Public Count: 0.
