#### § 163-165.1. Scope and general rules.

(a) Scope. – This Article shall apply to all elections in this State.

(b) Requirements of Official Ballots in Voting. – In any election conducted under this Article:

(1) All voting shall be by official ballot.

(2) Only votes cast on an official ballot shall be counted.

(c) Compliance With This Article. – All ballots shall comply with the provisions of this Article.

- (d) Other Uses Prohibited. An official ballot shall not be used for any purpose not authorized by this Article.
- (e) Voted ballots and paper and electronic records of individual voted ballots shall be treated as confidential, and no person other than elections officials performing their duties may have access to voted ballots or paper or electronic records of individual voted ballots except by court order or order of the appropriate board of elections as part of the resolution of an election protest or investigation of an alleged election irregularity or violation. Voted ballots and paper and electronic records of individual voted ballots shall not be disclosed to members of the public in such a way as to disclose how a particular voter voted, unless a court orders otherwise. Any person who has access to an official voted ballot or record and knowingly discloses in violation of this section how an individual has voted that ballot is guilty of a Class 1 misdemeanor. # Henderson County Board of Elections Minutes of Board Meeting May 24, 2024 CANVASS 2<sup>nd</sup> Primary

The Board of Elections met May 24, 2024, at 11:00 AM at the Henderson County Board of Elections office at 75 E. Central Street. Members present were Clay Eddleman, Chair, Debbie Dante, Secretary, Linda Rebuck, Sharon Pearson, Cindy Ellis, Members, and Summer Heatherly, Director. Staff present: Aaron, Vicki, Chuckie.

Pledge

Minutes were approved for 5/14/24

Agenda:

Linda moved to approve the agenda. Cindy 2<sup>nd</sup>. Passed unanimously.

Old Business: None.

New Business: Review, tabulate and add results of approved Supplemental Absentee Ballots, Complete Supplemental Abstract and Certificate of Oath. Received 4 Absentee Ballots on Election Day by 7:30 pm. 4 Ballots came in after the deadline. Opened Absentee Supplemental scanner; Public Count: 0. Scanned 4 Ballots. Closing Public Count: 4. Printed results tape; Board signed and completed the Vote Total Verification forms. Board was unable to call results due to voter secrecy. Unable to supply a copy of the tape to the public, for the same reason.

Review, tabulate, and add results of approved Provisional Ballots, complete Provisional Ballot Returns. Provisional scanner opened. Public Count: 0. Scanned 6 ballots. Closing Public Count: 6. Printed results tape; Board signed and completed Vote Total Verification. Board was unable to call results due to voter secrecy. Unable to supply a copy of the tape to the public, for the same reason.

Review and approval of total vote counts and voter history from Pre-Canvass audit and Final Canvass Spreadsheet. Director reviewed Final Canvass Spreadsheet. County turnout was 3.09%.

Board signed Final Abstract of Votes.

**Review Hand to Eye Count.** Rugby Precinct and Early Voting were chosen to recount. DS200 scanner compared with Hand Eye count was the same; Rugby Precinct 30 votes, Early Voting 661 votes.

**Commissioner letter.** Board approved draft letter to Chairman McCall (see attached). Chair noted he would be available for any questions.

**ID Exception form.** Board discussed draft letter to the State Board members, State Director, state legal, Senator Moffitt, Rep. Balkum, and all members of the House Election Law & Finance Reform Committee regarding the current Absentee By Mail ID Exception Form issues. Linda moved to send the letter as amended (see attached). Sharon 2<sup>nd</sup>. Passed unanimously.

**Directors Comments:** Director has requested feedback from the Poll Workers from both primaries. The 2<sup>nd</sup> Primary was small, but we took lessons learned that can be implemented in the November 2024 General. A lot of changes/improvements were made from the 1<sup>st</sup> primary to the 2<sup>nd</sup> regarding how supplies are packed up and the Chief Judge Manuel has been re-organized. We will not be using the vests any longer as they have outlived their age.

Director will be taking the state certification next year when they offer it, and she is looking into Federal Certification in addition to the state certification.

Director was asked what the payroll costs for the 2<sup>nd</sup> Primary were and she stated approximately \$30,000 (3.09% turnout-2,208 votes out of an eligible amount of 71,476 voters).

Debbie commented on the voter applications missing driver's license numbers or social security numbers and requested it be put on the agenda for the next meeting in October.

Debbie moved we recess for 5 minutes. Chair 2<sup>nd</sup>. Passed unanimously.

Reconvened 12:53 PM.

Sharon moved to go into Closed Session per NCGS§ 143-318.11(a)(6) to discuss personnel matters; Directors bonus. Linda 2<sup>nd</sup>. Passed unanimously.

There being no further business, the meeting was adjourned at 1:45 PM.

The Board respectfully requests that the form be updated to clarify the instructions and requirements for its use. Since all citizens must be treated equally, it should be made clear that in lieu of a photo ID, all voters, both in person and mail in, must provide either the last four digits of their Social Security Number or a NC Driver's license or NC state-issued ID card number.

In addition, the Board requests that this subject be placed on the August state meeting agenda.

On behalf of the voters of Henderson County, your efforts toward making this form clear and fair for all voters is appreciated.
