#### **SUMMARY OF REQUEST:**

The Detention Center is requesting that the Board approve the acceptance of an NCIC technology grant in the amount of \$18,000, to be used for a training opportunity. United States Corrections Special Operations Group (US C SOG) is a sole source agency for this unique corrections special operations training. The Detention division has been chosen as one of the few facilities to receive this type of training. This training will include: high intensity inmate conflict resolution, jail hostage rescue, major riot operations, high risk security patrol operations, responding to inmate violence, breaching operations, facility protection, low intensity inmate conflicts, to wit: dynamic cell extractions, minor inmate disturbances, vehicle extractions, high risk movement and transport. US C SOG is willing to provide these services to the Henderson County Detention Center for a price of \$39,770.

US C SOG is world renowned for their unique approach to operations and inmate management inside of a detention facility. It has proven in the past to be an effective tool to reduce use of force incidents, improve officer safety and provide the county with justifiable evidence in the response to high risk & high liability situations. This will not only improve safety for our officers but for the inmates as well.

#### Summary of CSO Proposal

The Henderson County Sheriff's Office has opted to enter into the Corrections Special Operations program. The purpose of the corrections special operations program is to enhance the current capabilities and offerings of the Henderson County Sheriff's Office Detention Center.

#### **Exclusive Invitation**

Henderson County has been selected to receive an official invitation to take their current Corrections Special Operations Team to a Tier 2 / Level 2 Unit through the "CSO Strategic Alliance Program. The purpose of this program allows US C-SOG to use the Henderson County Sheriff's Office – SOG as an example to our agencies within the state of North Carolina.

#### Uniquely Qualified to provide inter-agency Assistance

- The following areas of operations will make the HCSO uniquely qualified to provide an intensive and clear solution to the following situations within the state of North Carolina
- Trained and Certified to provide a competent conflict resolution to Operations to facilities operating within the operational matrixes of Direct Supervision, Traditional, Linear and Open Camp type of operations.
- Trained and Certified to provide a competent conflict resolution to Inmate Major Jail Riot through the certification of Close Quarter Riot Control
- Trained and Certified to provide a competent conflict resolution to Inmate Barricade Emergencies through the certification of Dynamic Cell Extractions
- Trained and Certified to provide a competent conflict resolution to inmate on inmate violence through High Risk Security Patrol Operations
- Trained and Certified to provide a competent conflict resolution to High Risk inmates Management System through Behavioral Managment Unit Operations



#### **Expectations of the CSO Program**

- The following is a general summary of the offerings and expectation that the Henderson County Sheriff's Office should expect to see as a result of having US C-SOG spear head the CSO Program.
- Henderson County, upon completion of the program, will be the only Tier 2 / Level 2 Sheriff's Office in the State of North Carolina and one of the few Level 1 Units in the Southeast Region of the US.
- Henderson County, upon completion, will be a Level 2 Jail SOG team within the state of North Carolina
- Henderson County Sheriff's Office Special Operations Group shall be trained and have the capabilities, capacity and technical ability to handle HIIC High Intensity Inmate Conflict which includes responding to and dealing with (Jail Hostage Rescue Operations, Major Riot Operations, High Risk Security Patrol Ops, responding to Inmate on Inmate Violence, Trained in Breaching Operations, Facility Protection) as well as deal with LIIC Low Intensity Inmate Conflicts to include but not limited to (Dynamic Cell Extractions, Minor Inmate Disturbances, dealing with Mentally III, Vehicle Extractions, High Risk Mass Movement etc.)
- Henderson County Sheriff's Office shall be provided with a clear policy and procedures template to accompany the program that meets both the ACA and State Standards.
- US C-SOG Shall Design and implement full Male/Female BMU Program.
- US C-SOG shall provide a clear, articulate, transparent and comprehensive selection process of Future HCSO SOG/BMU personnel.




