All bidders are hereby notified that they shall be properly licensed under the state laws governing their trades.

Bid security in an amount equal to not less than five percent (5%) of the gross amount of the bid is required.

Performance and Payment Bonds for 100% of the Contract Amount are required.

Brief scope of work for the base bid includes replacement of approximately 6,822 square feet of built up roof with 2 roof areas with the specified Fully Adhered PVC roof system in Area A and standing seam metal roof system in Area B.

A Pre-Bid Meeting is scheduled for 10:30 AM on July 24, 2018, at the HC Government Building, address listed above. Attendance is Mandatory.
