### **CALL TO ORDER/WELCOME**

Commission Chair Kathie Doole called the meeting to order at 1:31 P.M.

Ms. Hanson shared information received from the NC State Historic Preservation Office on Camp Pinnacle and Camp Ton-A-Wandah, specifically. Ms. Hanson also shared information on Camp Eagle's Nest, located in Transylvania County, also shared by NC SHPO. The Commission discussed the importance of summer camps in Henderson County and their contribution to the historical and cultural significance of the County. The Commission discussed plans to reach out to several camps for feedback on a potential program or historical recognition. Commission Vice-Chair Reid Barwick shared his experience meeting with the director of Camp Mondamin.

Staff and Commission members welcomed the newly appointed Flat Rock Representative, Anne Bryan Hanson, to the HRC. Staff shared that they are still waiting on the Historic Designation Plaque for the Samuel J. Childs House and will provide updates.
