Call to Order

Acting Chairman David Adams called the meeting to order at 10:03 a.m. He stated that the Chairman, Chuck McGrady was out of town, and the Vice Chair, Chris Burns was attending remotely, so he had been asked to serve as chair for this meeting.

Approval Meeting Summary

The committee approved the March 8, 2023, meeting summary by majority.

Updates

Conserving Carolina

Kristin Cozza, Greenway Coordinator with Conserving Carolina, stated that Conserving Carolina had selected TPD (Traffic Planning and Design, Inc) as the consultant to begin looking at the Saluda grade trail and connection to the Ecusta Trail. They hope to have a feasibility study ready next spring.

Friends of Ecusta Trail (FOET)

President Mark Tooley stated that TPD was also designing the Ecusta Trail for the Transylvania County portion. He stated that the FOET has convened a group of stakeholders to discuss operations and maintenance. This group is made of the two chairs from the Ecusta advisory committees, staff, and representatives from the FOET and Conserving Carolina. He also stated that the FOET had selected a consultant to look at branding options for the trail.

City of Brevard

Mayor Copelof stated that the FLAP grant funds had been released for the preliminary engineering of their portion of the trail and they are working with TPD on a scope of work.

Henderson County

Marcus Jones said that the County is working with NCDOT on some final issues and scheduling, but phase I is still on schedule for delivery this year into next spring. He stated that the timing of the paving season may delay final surface coat to next spring. He also stated that until the public bids for construction come, we do not know the true budget of cost, but the 30% cost estimate is still on target.

Trail Maintenance

Chris Todd stated that the RTAC had briefly discussed trail maintenance. He said that the County is working with the City of Hendersonville, the Town of Laurel Park, and the FOET on maintenance and the MOU. The RTAC will have an opportunity to discuss any types of maintenance issues such as repaving needs/fixes and mowing.

Draft MOU Discussion

Chris Todd provided handouts on the DRAFT MOU. He stressed that this is a draft that will have updates or even amendments later as the trail maintenance and other activities are continued to be discussed. He stated that the County is working with the other jurisdictions, including the FOET and Conserving Carolina on the MOU. He also stated that the MOU may include the City of Brevard at a later date. He stated that the MOU discussion with the other jurisdictions and the RTAC may take a few meetings to fully discuss and finalize. The Draft MOU provides and overview of the history, scope of project, and daily maintenance. It will also provide for cost share discussions on maintenance and repairs. Henderson County would be the responsible party for the Henderson County portion as per the lease. He stated that all partners have a voice, and the public knows this is a community project. Conserving Carolina is actively looking for connections to the trail. A PDF of the MOU will be sent to the RTAC.

Other Discussion

Staff answered questions on the current engineering work and process. Staff also noted that the County should hear anytime on the NSFLTP grant awards and RAISE will be announced at the end of June.
