<u>Call to Order:</u> The meeting was called to order at 12:06 PM by Chair Summey.

<u>Approval of Minutes:</u> No changes were requested. Mr. Boyd made a motion to approve the minutes, Mr. Wilson seconded the motion. All present were in favor, the minutes were approved.

Director McFalls then highlighted several areas of the March Statistical Report (Attachment III). Work First Employment continues to stay low due to the unemployment rate being low. Medicaid Transportation is higher and then lower. This is calculated when billed and paid so it isn't that we are doing more, just billed more. Foster Care (18-21) is up 20% over 13 months. This is good because when they age out they are asking us to help them as they make the transition to adulthood. Guardianship cases are down.

<u>Program Administrators Reports (Attachment IV):</u> Social Work Program Administrator Marino reviewed his report. In observance of Child Abuse Prevention Month, pinwheels were placed by the sign along Spartanburg Hwy and a wreath that was made by Ms. Hope Pace is displayed in the lobby.
