Monthly Director's Report to Board of Social Services

- ~ NC FAST P-4: NCACDSS sent a letter requesting support in implementing one of the recommendations of the Social Service Regional Supervision and Collaboration Working Group (SSWG)to the Members of the NC General Assembly. The recommendation directs immediate reexamination of the plan to use NC Fast for case management in adult and child welfare programs. A copy of the letter is included.
- ~ On March 11, 2019 H.B.320, Suspend Child Welfare/ Aging Component/ NC Fast was filed. The bill, if passed would require DHHS to suspend development of the NC Fast system as related to case-management functionality for the child welfare system and aging and adult services' programs. We have been informed that work will continue on implementation of NC Fast until such time this or another bill becomes law requiring the work to stop. Henderson County is scheduled to go live in case management on July 22, 2019. A copy of the bill is included.

- ~ The Henderson County Substance Abuse Task Force held its final meeting in late February. Final work is being completed and the report is expected to be released in April 2019.
- ~ We have hired for all positions in economic benefits and currently have three positions open in social work services.
