Mr. Beau Waddell, Chair at-large, called the meeting to order at 4:00 p.m.

#### **Public Comment:**

The TAC heard from one member of the public concerning the presentation at the last meeting on automous vehicles and the importance to plan for the future of this technology.

#### **Approval of Agenda and Minutes:**

Vice Mayor Anne Coletta moved to approve the agenda. Mayor Shanon Gonce seconded the motion. Motion passed.

#### **Discussion:**

#### Discussion on Prioritization (P 7.0)

After a multi-year pause due to a multitude of factors, the NCDOT is pushing forward with another round of SPOT. Mr. Tristan Winkler, FBRMPO Director provided a presentation and overview to the TAC on the next round of prioritization (P 7.0). Mr. Winkler asked the TAC to provide a list of projects to submit for preliminary scoring. Specifically, Henderson County needs to submit seven highway projects and seven bike/ped projects. The MPO will do a round of amendments to the Comprehensive Transportation Plan (CTP) if needed since any project scored must be in an adopted plan, either the CTP or MTP. There are existing projects that are considered carryovers that did not make the cut in P6, and they will be rescored automatically and not count towards the County's total projects. Different from previous rounds, the state's new Complete Streets Policy is in place so any bike/ped project submitted that is in a locally adopted plan (e.g., Henderson County's Greenway Master Plan) will be 100% covered by NCDOT just like a regular road project. A 20% match will be required for any project not in a locally adopted plan. This is the very beginning of the process, and the TAC will continue to be involved for months to come, just like in the past rounds of SPOT. Based on meeting discussion, it was requested that Mr. Winkler return in July and the group discuss these projects further.

#### Village of Flat Rock

#### Town of Laurel Park

Councilman George Banta reported that the Council let a bid for their road pavings. Work will begin soon and hopefully finish by early fall.

#### Town of Mills River

Mayor Gonce did not have any transportation updates.

#### City of Hendersonville

No updates.

#### Town of Fletcher

Councilman Davy thanked NCDOT for meeting with residents who were concerned about I-26 road noise and a possible sound wall.

#### At-large/Staff Updates

Mr. Joe Sanders shared that he was approached by folks who are concerned about the visibility on Ransier Rd. off of Hebron Rd in Laurel Park and the County's jurisdiction. NCDOT will follow up.

Mr. Sam Henderson asked for clarification on the cascading of the US64/I-26 interchange; Tristan let him know there is no overlap.

Mrs. Autumn Radcliff stated that the comment period is still open until July 15<sup>th</sup> for the bridge replacement on US 64. She also gave an update about fellow staff member, Janna Bianculli who is recovering from injuries related to a car accident. Mrs. Radcliff stated that she would make any meeting materials available upon request.
