Mr. Beau Waddell, Chair at large, called the meeting to order at 4:00 p.m.

Public Comment:

The TAC received comment electronically, but there were no comments at the meeting.

Approval of Agenda and Minutes:

Vice Mayor Anne Coletta moved to approve, and member-at-large Sam Henderson seconded the motion. Motion carried.

Discussion:

Conference Recap

Member-at-large Dawn Barr presented information she learned when attending the NC Traffic Safety Conference. She stated that the conference's purpose is to "help us understand new perspectives of what is driving transportation safety and expand our knowledge of ways to reduce and eliminate crashes" to achieve Vision Zero. Vision Zero is a collaborative initiative to eliminate roadway deaths and injuries in North Carolina. Mrs. Barr stated that much of the conference was focused on methods to accomplish this mission, including slowing traffic, which our region is currently facing with many 55mph roadways being reduced for safety. Councilwoman Jennifer Hensley shared that the City's WalkHendo Plan addresses many pedestrian concerns in Hendersonville.

Henderson County Compression Braking Ordinance

Mrs. Janna Bianculli presented two public comments received about noisy compression brakes. One was related to Banner Farm Rd and the other concerned I-26. Mrs. Bianculli presented the steps Henderson County would need to take to adopt a compression brake ordinance. She shared that even if such an ordinance is adopted, it would be an amendment to the noise ordinance and would only be enforceable by the Sheriff's Department, which does not monitor state roadways (there are no county roads in the state of NC) since that is the job of NC Highway Patrol. After good discussion, Commissioner McCall stated that she believes the noise on I-26 will diminish once construction ends. She suggested the TAC wait to provide a recommendation until after that time.

WNC Safe Routes to Schools

Ms. Ada Sloop from Land of Sky Regional Council presented on our region's newly created Safe Routes to Schools program. She stated she is working with Hendersonville Middle School based on the superintendent's advice. A discussion was held concerning Bruce Drysdale Elementary School and the ban on walking as a mode of "picking up or dropping off" a student. Ms. Sloop said Bruce Drysdale is not on her list now, but she hopes to work with them due to their proximity to downtown and pedestrian infrastructure. The TAC expressed confusion over the School Board/safety personnel's decision to ban walking and wanted to investigate further. Mr. Henderson motioned for the TAC to send a recommendation to the Board of Commissioners to discuss the topic and investigate why the decision was made. Councilwoman Jennifer Hensley seconded the motion. Motion carried.

Updates:

NCDOT Update

Please see the attached document for construction and development updates. BOT Representation Chuck McGrady shared that the Board continues to travel around the state for meetings.

Henderson County

Commissioner McCall stated she was asked about the landscaping maintenance inside the Greenville Hwy roundabout. She also noted the Commissioners voted to create an easement for the extension of the Oklawaha Greenway through Berkeley Park.

Town of Laurel Park

Councilman George Banta said the recent heavy rains damaged culverts and washed-out roadways that the Town is working to fix (if a town road). He also stated they are looking for emergency funding from the state to help with these efforts.

Town of Mills River

Mayor Shanon Gonce asked what modes would be allowed on the Ecusta Trail. He also followed up on a previous update regarding a roadway safety issue at Glen Marlow Elementary. Mayor Gonce has teamed up with Councilman Jim Player to work on solving this issue.

City of Hendersonville

Councilwoman Hensley stated they are waiting on AT&T before finishing the 7th Ave. project. She also mentioned her work on the MTP workgroup and the update the MPO is currently working on.

The next TAC meeting is scheduled for September 18, 2024.
